



## ONLINE PRIVACY POLICY

Safe City Mississauga is committed to protecting your online privacy while providing you with the most useful and enjoyable web experience possible. This policy complies with all the requirements of the Personal Information Protection and Electronic Documents Act of Canada (PIPEDA), which establishes rules for the protection of an individual's personal information when it is collected, used, and disclosed for business purposes.

While you can use most features on the Safe City Mississauga website anonymously, you are required to provide personal information on some of our features.

### What Information Do We Collect?

We collect information from you when you register on our site, or fill out a form. When registering or filling out a form on our site you may be asked to enter your name, e-mail address, mailing address, or phone number.

### What Do We Use The Information For?

Any of the information we collect from you may be used in one of the following ways:

*To Send Periodic E-Mails:* The e-mail address you provide will only be used to send you information and updates pertaining to registration or the form you completed.

If you decide to opt-in to our mailing list, you will receive e-mails that may include organizational news, updates, or related information, etc.

### How We Use Cookies

Cookies are small pieces of information that some websites store on your computer's hard drive when you visit them. Like many other websites, Safe City Mississauga may use cookies to identify visitors. Most web browsers automatically accept cookies but allow you to modify security settings so you can approve or reflect cookies on a case-by-case basis. Even if you do not use cookies, you can still access all of the features on our site.

### Collecting Your Personal Information

We will ask you when we need information that personally identifies you (personal information) or allows us to contact you. Generally, this information is requested when you are making online donations, filling out a survey, registering for an event, and other services offered by Safe City Mississauga. Personal information collected by Safe City Mississauga's website often is limited to e-mail address, name, or mailing address, but may include other information when needed to provide a service.
